2. The space shall be kept neat and clean.
3. All buildings, tents, or displays are subject to the approval of the Association and must comply with food and health regulations.
4. Prices will be displayed and exhibitors display must not diminish as a result of sales. Application must conduct business from the space rented and from no other place on the grounds
5. Contract may be cancelled at any time by the Battlefords Agricultural Society for violation of any term regarding this contract or just for cause.
6. Spaces are rented on first come first serve basis. **No spaces will be reserved without full payment. NO REFUNDS after JUNE 15, 2017**
7. The application agrees to indemnify and save harmless the Battlefords Agricultural Society from any claim for damages arising from the use of the space, and / or service provided by the applicant during the term of this contract.
8. Products offered for the purchase must have CSA certification or appropriate government approval.
9. Exhibitors must park vehicles at designated spot behind the Agriplex Building, except during set up and take down times. Failure to do so may result in your vehicle towed at owners expense.
